





Article 2: "Everyone is entitled to all the rights and freedoms set forth in this Declaration, without distinction of any kind, such as race, colour, sex, language, religion, political or other opinion, national or social origin, property, birth or other status."

THE IMITATION GAME

Article 1 - Right to Equality: Alan Turing faces discrimination and prejudice due to his unconventional behavior and sexual orientation, highlighting the violation of his right to equality.

Article 5 - Freedom from Torture and Degrading Treatment: Turing undergoes chemical castration as a punishment for his homosexuality, which can be interpreted as a form of degrading treatment.

Article 9 - Freedom from Arbitrary Arrest, Detention, or Exile: Although not explicitly depicted in the film, Turing's arrest and prosecution for "gross indecency" under antihomosexuality laws represent a violation of his right to freedom from arbitrary arrest.

Article 12 - Right to Privacy: The surveillance and invasion of privacy depicted in the film, both by the government and society at large, call into question Turing's right to privacy.

These violations and themes underscore the broader societal challenges surrounding discrimination, privacy, and the protection of individual rights during Turing's lifetime.

Despite historical inaccuracies, such as the name of Turing's computing machine, the film captivates with its acting and screenplay. Moments depicting wartime scenarios or Turing's past memories intertwining with present events are particularly engaging. The film also narrates events related to the birth of computing tools, presenting various technologies considered precursors to modern technology. These include the "Bomb," developed by Turing's team to decipher Enigma, representing one of the earliest examples of electromechanical computers.

THE HELP

Article 3: Everyone has the right to life, liberty and security of person.

Article 4: No one shall be held in slavery or servitude; slavery and the slave trade shall be prohibited in all their forms.

Article 5: No one shall be subjected to torture or to cruel, inhuman or degrading treatment or punishment.

Article 7: All are equal before the law and are entitled without any discrimination to equal protection of the law. All are entitled to equal protection against any discrimination in violation of this Declaration and against any incitement to such discrimination.

Article 23: Everyone has the right to work, to free choice of employment, to just and favourable conditions of work and to protection against unemployment.
